To better gain information pertaining to student understanding, interest and Contract challenges with college life, Hill College participated in two external student surveys this fall.

1. The **Student Financial Wellness Survey** – The survey was designed by Trellis Research (formally TG).

63% of respondents worry about having enough money to pay for college




### DATA BITES: GRADUATION RATES

How do we stack up to similar institutions? How do we stack up to the State? The graphics below give a glimpse of how well Hill College aligns with Medium Community Colleges and Statewide:

#### **FULL TIME STUDENT 3-YEAR GRADUATION RATE**

The percentage of first-time, credentialseeking undergraduates who graduate within 3 academic years. Those students who enrolled in their first fall as full-time students (taking 12 or more semester credit hours) are included in the cohort. Both degrees and certificates are included.





#### PART TIME STUDENT **3-YEAR GRADUATION RATE**

Those students who enrolled in their first fall as part-time students (taking fewer than 12 credit hours) are included in the cohort. Both degrees and certificates are included.
