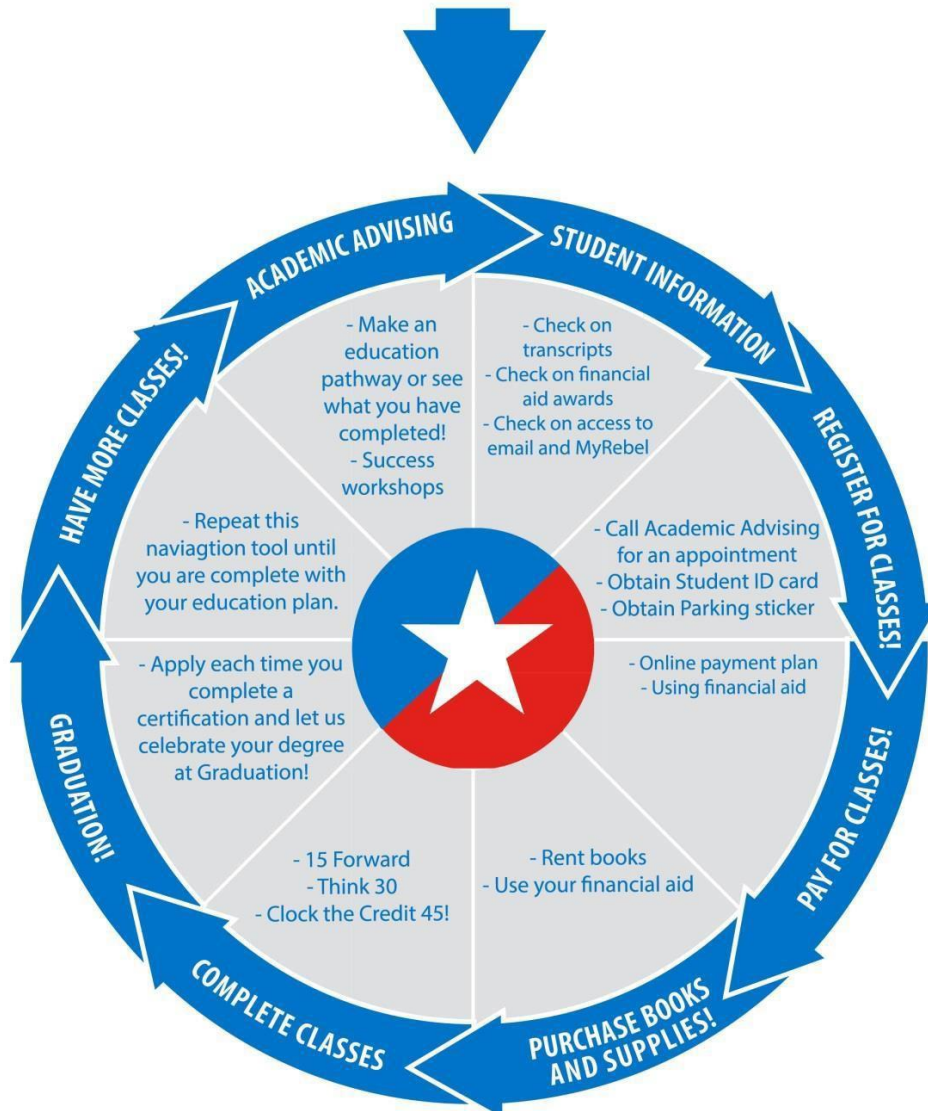
Cosmetology is more than cutting hair... It is a profession that will tap into and develop every talent you possess and is only the first step in shaping your destiny.
